Revision of Annual Membership Fee from the Financial Year 2025-26

Dear Professional Members,

Greeting from ICSI IIP,

In terms of bye-law 11 of Bye Laws of ICSI Institute of Insolvency Professionals require every Professional Member (enrolled with ICSI IIP) to pay an Annual Membership Fee to ICSI IIP.

We are pleased to inform that the Governing Board of ICSI IIP, in its meeting held on 31 December 2024 has 'Approved' to (1) Revise Annual Membership Fee Structure, (2) Introduce AFA Fee, and (3) Revise One-time Enrolment Fee Structure for New Entrants with effect from 01 April 2025 (i.e., F.Y. 2025-26 onwards).

The details of Fees payable effective from 01 April 2025 are as follows:

3	IP as an Individual	One-time non-refundable Enrolment Fee worth INR 5,000/- + GST as applicable to be paid along with the Enrolment Application	<i>One-time non-refundable Enrolment Fee Payable at INR 2,000/- + GST as applicable for New Entrants at the time of Enrolment only</i>

In view of aforementioned, we request all the professional members to renew your membership for the financial year 2025-26 with ICSI IIP by remitting the Annual Membership Fee. The amount has become due for payment effective from 01 April 2025 and needs to be paid on or before 30 April 2025.

- 1. The fees can be paid only through online payment gateway of ICSI IIP. No fees shall be accepted through any other mode. In case of non-payment of annual membership fee, Authorisation for Assignment (AFA) shall not be issued.*
- 2. If there is any default in payment of any previous years' annual membership fee, then kindly clear all your dues. Delay in payment beyond due date may attract late payment fee or other penalties, as applicable*
